**Subject: Conversion of Existing Single Point Connection to Multipoint Connections**

We write in reference to our earlier letter No. E-158/SP-MP/FY 2020-21/FN-109, dated 17-07-2020, wherein, it was communicated to you that if the RWA / AOA wants to retain the Single Point Connection, it should communicate the same (through majority resolution) to NPCL within 30 days from the date of the letter; otherwise, it will be considered that your housing society has opted for Multi-point Connection and appropriate action will be taken accordingly.

Since, we have not received the majority resolution passed by the RWA /AOA; it is deemed that you have opted for multi-point connection. In order to proceed for implementing multipoint connection, we need the following documents / information as was informed vide our above-referred letter dated 17-07-2020.

- Detailed Load Calculation of your Society including Common area.
- List of Owners / Allottees along with details containing the Name, Flat No., Contact No., present sanctioned Load (kW).
- Single Line Diagram and Layout Plan of your Society (duly approved by GNIDA), clearly indicating therein the location of the Substation, Transformer(s), Cable route, LT Panels, Feeder Pillars, Metering Panels etc. along with the NOC from Vidyut Suraksha Nirdeshalay, Govt. of Uttar Pradesh.

You are, therefore, once again directed to submit the above documents within 15 days from the date of this letter, so that inspection / verification of the installed Electrical Infrastructure vis-à-vis the same shown in the drawings / documents, yet to be submitted by you, can be done immediately in order to provide direct Electricity Connection to the individual residents. Please note that the support & Cooperation from AOA / RWA / Builder / Developer is required for smooth conversion from Single Point to Multi-Point Individual Connections.
